  - a. You have any doubt as to the authenticity (as to which you shall be the sole arbitrator) of any signature on any such Fax / E.mail
  - b. any such Fax / E.mail is mutilated or unclear in any respect.

Not with standing anything herein contained, you shall be under no obligation to enquire into or confirm the authenticity of any signature and in the absence of any obvious discrepancy shall be entitled to act on such instructions on such signature(s) and reply in these modes as per the above mentioned details. I/We further understand and accept that it is entirely my/our responsibility to maintain such Fax/email accounts (including the login ID, passwords, etc thereof) securely, free of any hacking/phishing attack etc.
4. I/We undertake to send to you promptly a signed original of each Fax / E,mail, but my /our obligation to you in respect of the instructions contained in Fax / e.mail shall not be effected by an failure or delay on my / our part in sending original.

I/we hereby undertake to indemnify you and save you and save harmless from and against all cost, claims, damages and proceedings that may arise or that you may suffer or incur by reason of having accepted and acted on instructions transmitted by Fax /E.mail.
